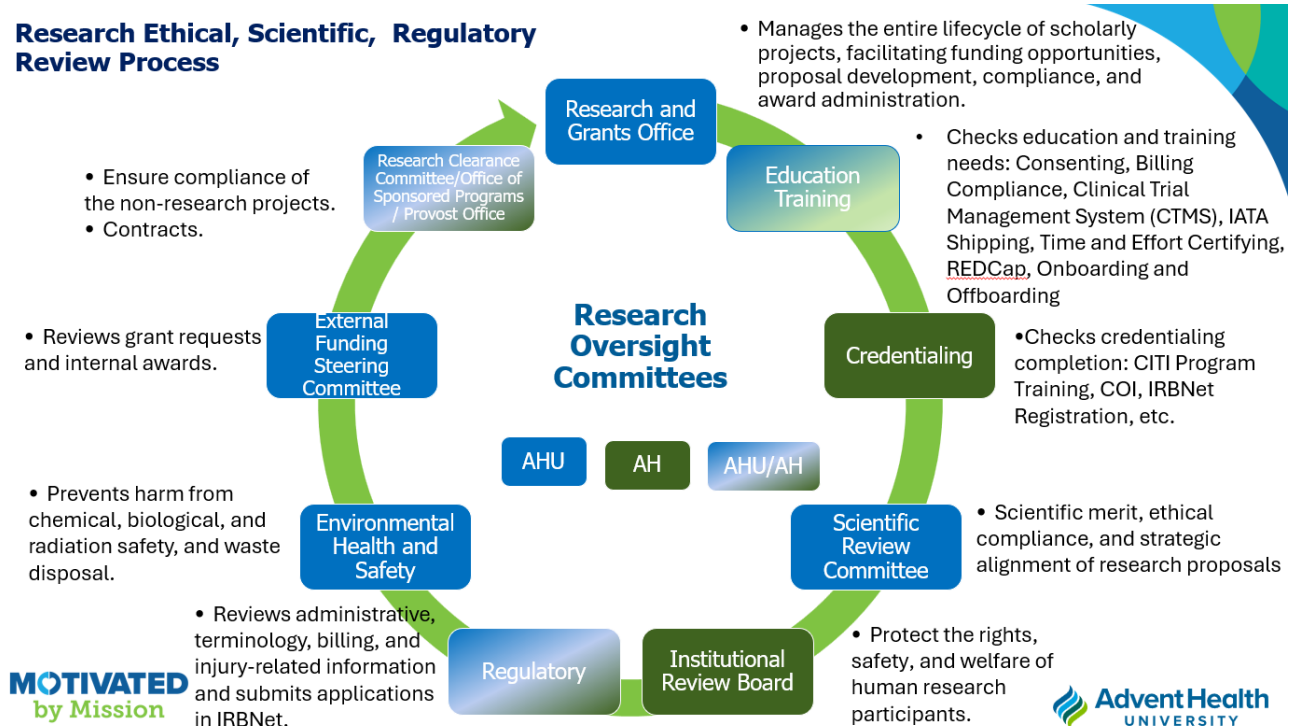

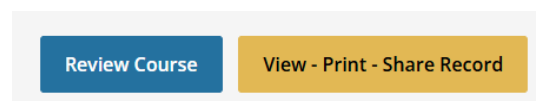
3.4 Passing Score:

A quiz will appear at the end of each module. **The passing score per module is 80%.**

You can repeat CITI quizzes as many times as necessary to achieve the passing score, with no stated limit on the number of retakes for a single quiz. To retake a quiz, you should scroll to the bottom of the exam results page and select the option to "View this Module Again".

3.5 Certificate and Expiration:

At the end of each course completed, you will be able to access and download your **Certificate of Completion**. Navigate to the page for your completed course and click the **"View-Print-Share Record"** link next to the certificate option.



Clicking on this "yellow" link will generate another page with **two PDF download options**: the **"Completion Report"** and the **"Completion Certificate."**

Completion Report	Completion Certificate
Completion Reports are transcripts of your course work, and include all quiz scores. Part 1 shows scores "frozen" at the time you completed and passed the course. Part 2 reflects scores for any subsequent quiz attempts.	Completion Certificates are "diplomas" that reflect course completion, but do not include quiz scores. Certificates are suitable for sharing with persons who do not need to see your quiz results, or posting online.

4. Completion of Conflict of Interest (COI) Training and Disclosure Form

4.1 COI Definition:

A conflict of interest (COI) in research arises when an individual's personal interests, particularly financial, could compromise or appear to compromise their professional judgment and integrity in conducting or reporting research. All individuals conducting research (except students), research administrators, and research committee members must complete the **conflict of interest (COI) training** and **submit the signed disclosure form**.

4.2 COI Training:

Complete the **CITI training under Question 3, Responsible Conduct of Research:**

- RCR Research Review Committee.
 - o The module Conflicts of Interest and Commitment (RCR-Basic) (ID 16599) is part of the RCR course.

Training is **valid for 5 years** as described in the Certificate.

4.3 Research Conflict of Interest Disclosure Form:

Complete and sign the **AHU Research Conflict of Interest (COI)** and/or **AHU Significant Financial Interest (SFI) Disclosure Form(s)**. Note: The SFI disclosure form is only required if you have any financial interest to report as it relates to your **Institutional responsibilities**.

COI disclosure needs to be completed **annually, during the renewal of the research committee membership**.
